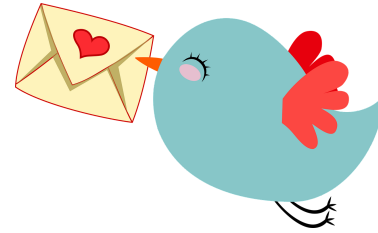

### Membership FAQ for 2020-21

**Q:** My license is up for renewal. Can I still join FCCA if DEEC hasn't given me my new license yet or my license states that it is expired?

**A:** Yes! If you are a member from the previous year, 2019-20, and you are reapplying for 2020-21 membership year, you can use your most recent license.

If you are a new member, please submit a current license.

**Q:** My license is current, but my program isn't opening yet. Can I still join?

**A:** Yes! FCCA requires that you hold a valid FCC license from DEEC to join. You do not have to currently be working in an FCC program.

**Q:** I have a great idea and I am interested in teaching a workshop for FCCA. What should I do?

**A:** We are still working out the details and plan to get them out very soon. The board will review proposals from members and accept up to 3 workshops to host. Workshop presenters must meet qualifications set by DEEC (which includes experience and/or education requirements). If your proposal is accepted, you will get a free membership for the year.

**Q:** How do more frequent and smaller classes work for CPR and First Aid?

**A:** We are still working out the details and plan to get them out very soon. We are looking for up to 6 members who would host a CPR/FA at their home for groups of 6-9 people. Ideally, classes would be held outdoors. Indoor classes would require enough space to physically distance. Members who host a CPR/FA class this summer or fall will get a free membership for the year.

**Q:** Does FCCA have new bylaws?

**A:** Yes. The board met virtually on June 18. We did our oath of office, held a Q&A and submitted proposed changes to the draft bylaws, and voted unanimously to adopt the organizational bylaws. They will be sent to members via email and posted on the website.

**Q:** Is there a schedule of events yet?

**A:** Not yet! We're working on it and will let you know as soon as we have events confirmed.
